When you complete and submit a Seniors Card application form to the Directorate or COTA ACT, your personal information is collected for the following purposes:

1. to provide you with an ACT Seniors MyWay Card;
2. to help you use your ACT Seniors MyWay Card, including to access senior's entitlements, events and travel concessions, or to replace lost or stolen cards;
3. to provide you with information and updates about your ACT Seniors MyWay Card; and
4. to ask you to participate in surveys about the Seniors Card Program, including the Seniors Card Information Service and entitlements.

• The Directorate passes on information collected on the application form to COTA ACT and to its MyWay Ticketing System Service Provider. COTA ACT passes on information collected on the application form to the Community Services Directorate.
